

THE CASE AGAINST MIKE GABLEMAN

Former Ashland County District Attorney Mike Gableman co-hosted a fundraiser for then-Governor Scott McCallum on June 12, 2002. Prior to the fundraiser, a series of telephone calls were placed from his public office to McCallum's campaign staff and to individuals who contributed to McCallum's campaign. Numerous other calls that may have had a political purpose were also placed from his public office. Gableman has acknowledged making personal calls from his public office.

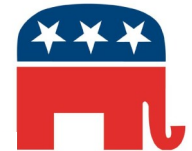
